PPF Small Grants Program Application Guidelines Application Instructions with Sample Letter of PP&R Support

The Portland Parks Foundation's Small Grants Program awards financial support to community-based organizations within the city of Portland who foster equitable access to our urban parks, natural areas, community gardens and community recreation centers.

Our motto is *"We help people help parks"* because we know that our parks support so many of our personal and community needs. Parks can improve mental and physical health, serve critical green infrastructure functions, contribute to economic development, act as links in transportation networks, host cultural and social activities, and help give communities a sense of place.¹

Yet many Portland residents still lack equal access to parks that feel welcoming and safe. They struggle to find well-maintained parks that are designed and programmed to meet their particular needs, based on input from their community.

With our small grants, PPF focuses on the people and organizations working to fill these gaps. We intentionally prioritize organizations supporting low-income populations, communities of color, and other historically marginalized groups.

2024 Grant Funds:

During each of the Spring and Fall Cycles, PPF will support 12 projects or organizations with a \$2,000 grant each.

Who can apply:

Community-based/grassroots organizations who care for or provide programming in public parks, nature spaces, community gardens or community centers **THAT ARE:**

- Located within the city of Portland **AND ARE A**
- 501(c)(3) organization, or a non-501(c)(3) organization applying with a fiscal sponsor*,
- **AND HAS** Not received Small Grants Funds from PPF for the last 12 months

What you can apply for:

- **General Operating Support** (Unrestricted funding) for organizations that are clearly aligned with PPF's equity mission (see below).
- **Project Specific Support** for eligible programming that is planned to take place within 12 months of receiving the grant.

Examples of projects PPF considers competitive include, but are not limited to:

- PP&R permitted collaborative events in parks.
- Virtual engagement that builds relationships for multi-generational, multicultural Portland residents with natural spaces and parks.
- Targeted marketing or capacity building (i.e. staffing/COVID related equipment)
- Community gardens support
- Community-based TLC, such as seasonal clean-ups or plant care

Projects that require approval or permits from Portland Parks & Recreation or other government agencies must include documentation of their approvals with the application. For example, projects that involve ticketed events in a park or scheduling of a work party are likely to require PP&R review and approval.

NOTE: For both types of grants (general operating and project specific support), PPF will prioritize organizations that align with PPF's mission to promote equitable access for all Portlanders to parks and parks programming and prioritize low-income populations, communities of color, and other *historically marginalized groups.

* PPF defines historically marginalized groups as anyone who has experienced inequities as a result of their class, race, ethnicity, citizenship status, nationality, disability, religion, gender identity, sexual orientation or age. We recognize that this list is not comprehensive and strive to prioritize all groups that experience inequities as a result of how they identify or are identified by others.

Prepare for your Application

Information you will need on hand...

- A list of project or organization leaders along with their email and phone contacts
- 501(c)(3) tax determination letter or documentation of fiscal sponsorship
- Letter of project approval from PP&R or associated agency (if applicable - A sample is attached to this document)

Preview Application and Draft Answers

- Preview the application questions. An example is attached at the end of this document.
- Draft your application questions, if desired:
 1. Tell us about your organization's mission. If applying for a specific project, tell us about the purpose of your project.
 2. How will this PPF grant help your organization/or project (please provide 2-3 examples)?
 3. How does your organization or project align with PPF's mission to promote equitable access for all Portlanders to parks and parks programming and center low-income populations, communities of color, and other historically marginalized groups (please provide 2-3 examples)?
 4. Tell us about your current partnerships, collaborations or communities you work with (Examples: organizations, schools, neighborhood associations, churches, etc.).
 5. **ONLY FOR PROJECT SUPPORT APPLICANTS:** If your proposal is project-based, please provide:
 - a. timeline for completion AND
 - b. a project budget.




Submit Your Application
